BPUT SCHOLARSHIP

Government of Orissa has instituted several merit-cum-means scholarships amounting to Rs.10,000/- per student per annum for students studying professional courses in Technical Institutions inside and outside Orissa that are enacted by State Legislation or recognized by AICTE or UGC or by respective State Legislations.

Eligibility Criteria:

- i) The student must be a permanent resident of Orissa.
- ii) The annual income of parents from all sources shall not exceed Rs.4.5 lakhs.
- A student already in receipt of any scholarship can not avail this scholarship unless he/she opts to forgo the other scholarship.

Essential enclosures

1 Original Resdential Certificate.

2 Original income certificate of parents from employer and/or appropriate authority countersigned.

4 Attested copy of mark sheet of last qualifying examination.

5 Attested copy of pass certificate of 10th Std. Exam/+2 Exam/Degree Exam, whichever is applicable.

6 Boarder certificate if the applicant applying for Scholarship to Teacher's Children (STC) is a Hosteller

7 Attested copy of rank card issued by the chairman of OJEE/All India Test.

8. Service certificate as in Appendix-C from Headmaster of the school & countersigned by DI/CI of schools, (applicable for STC)

9 Self attested (on front) passport size photograph to be pasted at the front right corner of the CAFAS.

10 Attested copy of the Bank Pass Book showing name the applicant & account number.

GUIDELINES FOR OPERATION OF WELFARE FUND

- 1. Only the registered students of BPUT and other Universities admitted during the year 2002-03 and thereafter are eligible to get the benefit of Welfare Fond provided the concerned student has contributed to the same fund during his/her admission.
- On death of father/ Enhancing guardian of the student. The student concerned will make an application to the Principal of the College in duplicate with a copy of the death certificate.
- 3. The College will constitute a committee with the Principal as its Chairman and two other Heads of Departments Including the Departmental Head of the student concerned to examine the case in derail. The committee will also calculate the estimated financial requirement year wise for the student to complete his/her study.
- 4. The Principal will send the letter with specific recommendations and enclosures to the Registrar Biju Pattnaik University of Technology.
- 5. For each application, a Committee comprising the Registrar, the Director Examination, the Finance Officer and the concerned College Principal will be formed to consider the application for support from Welfare Fund and quantity the amount to be sanctioned.
- 6. On recommendation of the Committee, the Vice-Chancellor shall sanction necessary support from Welfare Fund.
- A letter will then be issued by the University to the College concerned conveying the decision on the proposal under intimation to the Director, Technical Education & Training Orissa and Industries Department.
- 8. University shall place the sanctioned amount directly in favor of concerned college. The amount so sanctioned shall be kept in a Bank Account to be jointly operated by an official of the College and the student concerned.
- 9. The entire process shall be completed within a period of one month from the date of receipt of the complete set of application.

- 10. The utilization Certificate shall be signed by both the Principal of the concerned College and Finance Officer of the University and countersigned by the Vice- Chancellor being the sanctioning.
- 11. The fund will be audited every year and BPUT will keep Govt. informed on the issue.
- 12. The guideline will come in to effect immediately. All pending cases will be disposed off treating the date of contribution as the effective date of eligibility. Full reimbursement actual costs as per eligibility will be made expeditiously in such cases.
